3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to KIT-Kalaignar Karunanidhi Institute of Technology, Kannampalayam(Post), Coimbatore- 641 402, Tamil Nadu as a whole.
