## **OM ANY OTHER MATTER OF ACADEMIC IMPORTANCE**

- OM 1** The Anna University Nominee sought clarification on the modification of Continuous Internal Assessment (CIA) from three to two, and it was clarified that the change was implemented as per Anna University norms.
- OM 2** The UGC nominee suggested that conference paper and journal publication should not be made mandatory for the completion of student projects and that students should be given adequate time and academic support to publish quality research outputs.
- OM 3** Emphasis was laid on the need to increase publication of papers in reputed journals and to improve the research output of faculty members.
- OM 4** The Academic Expert suggested that students completing more than three certifications through SWAYAM, NPTEL, Coursera and other value-added platforms may be given additional academic credit or recognition.
- OM 5** Faculty members across departments were encouraged to publish more research papers and work towards achieving higher research performance indicators.
- OM 6** It was suggested to increase the number of full-time research scholars and to promote interdisciplinary projects.
- OM 7** The need to improve skill-based courses was highlighted, with a recommendation to involve external experts in assessment.
- OM 8** Introduction of Spanish language under foreign language studies was suggested to enhance global employability of students.
- OM 9** Measures to improve vertical mobility, enabling more KIT students to pursue postgraduate programmes, were recommended.
- OM 10** Faculty members and mentors were advised to be actively involved in guiding students for industrial and multidisciplinary projects, with support from technical staff.

## **GS GENERAL SUGGESTIONS**

- GS 7.01** Members suggested that the exact number of students participating in external events should be clearly mentioned in future presentations.
- GS 7.02** It was advised that with the increase in U.G. intake, the institution should appoint adequate qualified faculty members rather than relying mainly on industry experts.

- GS 7.03** Clarification was sought on the introduction of new programmes such as BBA and BCA, and it was suggested that priority be given to stabilizing engineering programmes.
- GS 7.04** The need to include staff retention and promotion details in academic presentations was emphasized.
- GS 7.05** It was suggested to recruit sufficient technical staff to support faculty in research and project activities.
- GS 7.06** Infrastructure facilities were advised to be strengthened in proportion to the increased student intake.
- GS 7.07** Young faculty members were encouraged to be recruited to support academic and research growth.
- GS 7.08** Appreciation was expressed for consultancy revenue of ₹10 lakhs, with a suggestion to further motivate faculty to enhance consultancy and funded projects.
- GS 7.09** Equal opportunity was recommended for Ph.D. scholars from other institutions during admissions.
- GS 7.10** The members appreciated the pass percentage of 91.42 and suggested motivating students towards start-up and entrepreneurial activities, considering the institute's industrial location.
- GS 7.11** It was suggested to increase international collaborations and the number of active MoUs.
- GS 7.12** Inclusion of student grievance redressal details, dropout rate, CSIR activities, and Alumni Association activities in future presentations was recommended.

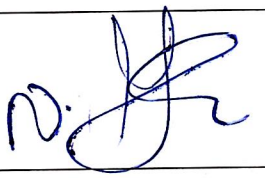

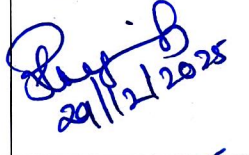
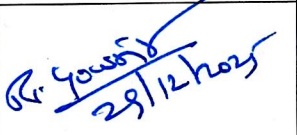
